Jeanne began her career in the Los Angeles County District Attorney's office in 1988. Eight months after joining the office she had her first felony trial and at the time of her departure she was assigned as the sole prosecutor on a death penalty multiple defendant matter. In less than five years she tried over sixty criminal cases.

Jeanne moved to Orange County to join the civil firm of Alevizon Smith Susson & Palafox practicing both plaintiff and defense, including construction defect, premises liability, personal injury and catastrophic injury matters. She followed her husband to Singapore, where they lived for almost five years. She taught business law and political science at The Overseas Family College, which is affiliated with the California State System. Her two children were both born in Singapore.

Jeanne returned to California and joined Smith & Marquart practicing both plaintiff and defense but focusing on the representation of peace officers, personal injury and product liability. The firm dissolved and she then became a partner in Smith & Behling and expanded her practice to include employment matters, sexual abuse and harassment cases.

As counsel Jeanne has participated in mediation throughout her career. She has been a student of mediation theory for twenty years and actively began to practice as a mediator in 2012.
